- Magic show \$1392 profit
- Fundraisers raised almost \$10,000
- Gaming grant \$10,000
- So far we've fundraised about \$48,000 this year
- Still have some funds leftover from last year so will not do raffle this year
- Raised \$3870 for private grad event. \$3700 will go grad ceremony event. Goal is to raise \$5000 for ceremony. Fundraising still ongoing for Camp trip with 6/7's.
