- Parent would be happy to pay for Fit Kids t-shirts in an effort to re-direct funds for the school playground as it seems to be an important need. PAC has donated \$9000 to the playground trust to date.
- Parent concerns around slippery sections on school property (icy conditions) where numerous children have fallen. Salting those areas (stairs, back of the school etc.) is critical to limit injuries. Leaves are also causing slipping hazard.
 Suggestion that School Admin assess and restrict access in areas that may be dangerous

for students and parents. Perception is that these concerns are not being taken seriously due to lack of visible action.

Boy's washroom – Feces on the ground and does not get cleaned regularly. Children wait until they get home to go the bathroom because they not want to go into the boy's bathroom. This could be quite uncomfortable for the children and a health & safety concern.

Perception is that these concerns are not being taken seriously due to lack of visible action.

- Parking Lot Cars are parked and left unattended on both sides of the barrier during start/end of school creating a bottleneck for cars. Potential solution may be adding more pylons to direct traffic flow.
- Crosswalk Mr. Taggar is volunteering. Follow up on school's request for a dedicated cross-walk person.
- There seems to be an increase in student conflict/physical harm what is the school doing about this? What is the school's approach – conflict management. Is WITS enough? Parents are not apprised of consequences which can be frustrating and perceived as lack of action to address.
- Is there a policy of electric scooters/skateboards on school grounds? They pose a safety hazard.
- How much money has been raised by the school from technology fundraising?
- Next Steps: PAC to share feedback with School Admin for potential solutions.
