 - o These should be readily available in all gender neutral AND girls' washrooms, if not parents should address with school administration. Contact DPAC if there are issues and concerns.

- District Ban on Donations for In-School Events 学区对校内事务捐款的限制
 - o Students cannot be asked to volunteer or donate money for events 学生不能被要求做 志愿者或捐款
 - o Students should not bring money to school 学生不能带钱到学校
 - o PAC can help fundraise for certain in school events 校家委会可以帮助筹集某些校内活动所需款项
- Portables可移动教室
 - o Huge financial issue for Surrey 对素里市来说是很大的财政问题
 - o A one-page information brochure is being created 待制作1页信息文件

- Indigenous Reconciliation, Truth, and Healing 原住民和解, 真相及治愈
 - o There are 3,250 self-identified indigenous students in Surrey 素里市有3250名自认同原 住民
 - o PACS should seek indigenous representation and invite indigenous parents to participate 校家委会应寻求原住民代表并邀请原住民家长参与
- Advocating for your students为学生做倡议
 - o A child getting extra support is not dependant on funding, regardless of IEP or designation. The funding formula is not the spending formula.

- o Document everything and follow up 记录各个事项并跟进
- o All students have a right to a full day educational program, with appropriate supports or accommodations 所有学生都有权参加有适当支持或场所的全日制教育课程
- o Know the appeal process if needed 若有需要的话,知晓申诉流程
- Surrey Safe Schools Presentation (Rob Rai) 素里市学校安全代表(Rob Rai)
 - o There is a police officer assigned to each school in the district, but they do not have offices within the school

- o Officers educate newcomers to the country to ensure safety and cultural awareness 为确保安全及多元文化意识,警官对刚来加拿大的居民进项普及教育
- o Children 12 and under cannot be charged under the Criminal Code of Canada 12岁及以下儿童不得根据加拿大刑法典被起诉
- Discussed bullying, parent notification when child (over 12) is being charged, police can talk to children without parent consent if there is an unfolding issue, teachers can not advocate to police on behalf of students as police do not know if teacher-student relationship is positive as well as it could also mean the teacher being called to court case goes in that direction.
