[1] CALL TO ORDER

Chairperson Wilson called the meeting to order at 7:00 p.m.

(d) <u>Presentation: Secondary School Apprenticeship</u>

Susan Chow, Principal, Career Education, provided Trustees with information regarding the Secondary School Apprenticeship Program.

The Secondary School Apprenticeship (SSA) is a career program that provides students with the opportunity to begin an apprenticeship while still in high school and to earn high school credits for doing so. It provides a smoother transition from school to work and a quicker route to certification in a trade. SSA students complete up to 480 hours of work experience that counts towards their apprenticeship and course credits. SSA youth apprentices must be 19 and under and complete their SSA work based training by 3 months past graduation.

To qualify for the Secondary School Apprenticeship Scholarships (value of \$1,000) must have:

- Been registered in the program in the school district prior to graduation;
- Graduated with a Grade 12 Dogwood Diploma or Adult Dogwood
- Successfully completed specific SSA courses
- Maintained a C+ average or better on Grade 12 level courses
- Continued working or training full-time in the trade 5 months after graduation or have 1100 hours report to the Industry Training Authority.

Thirty-five (35) SSA students were awarded a \$1,000 scholarship; however not all of them were able to attend the meeting this evening.

Chairperson Wilson, Trustee Allen, Dave Paul, Assistant Superintendent, formally presented the Secondary School Apprenticeship students with a scholarship.

A Bursary Award was also presented to a Buffy-Anne Troy, a student at Kwantlen Park Secondary in the Law Enforcement Preparatory Program. Lara Condella, LEPP Instructor, Chairperson Wilson and Dave Paul, Assistant Superintendent, formally presented the bursary to Buffy-Anne's mother on her behalf. Buffy-Anne was celebrating her high school graduation and was not able to attend the meeting.

(d) <u>Presentation: Student Ambassadors, Energy Conservation and</u> <u>Sustainability</u>

School Programs, provided Trustees with information regarding the Student Ambassadors program and the energy conservation activities

Students from 12 secondary schools in the district participated in the Student Ambassadors Program and provided Trustees with information on their activities. Highlights included:

- Gathered information about energy use and conservation in schools
- Participated in Green Teams and energy conservation clubs
- Visited elementary schools and promoted energy conservation
- Organized an Earth Day Festival and various Energy Conservation Week activities

The students are promoting the replacement of school hand dryers with a more efficient model. They are also asking all schools and/or administration to:

- practice conservation
- become waste free
- implement efficient washrooms
- convert to water bottle friendly fountains
- install lighting & heating upgrades
- design new buildings to be energy efficient
- provide access to coursework that explores day-to-day sustainability issues: energy, water and waste.

The Chairperson thanked the group, on behalf of the Board, for their insightful presentation and their continued efforts towards energy conservation throughout the district.

Anita Huberman, CEO, Surrey Board of Trade, as well as several Directors and/or members, provided Trustees with information regarding several Surrey Board of Trade initiatives and activities, including:

- K-12 skills needed by industry
- Advocacy update on capital funding
- Surrey Board of Trade Youth Leaders
- Surrey Board of Trade Student Entrepreneur Program

- Assistance with SD36 initiatives.

The Surrey Board of Trade would like their members to assist young entrepreneurial students in connecting with business people. It is one of the key deliverables of their strategic plan to have their Board Directors interface with students, especially students in grades 1-8.

The Surrey Board of Trade is very support of the K-12 and post-secondary education system. They will continue their advocacy from a business and economic perspective, to ensure that Surrey gets its fair share of funding.

WHEREAS the Board recognizes the right of the Province to establish system-wide assessments to monitor performance in specific areas of learning; and

WHEREAS the Board honours and celebrates the quality of the neighbourhood public school that provides a full range of education services to all children.

THEREFORE BE IT RESOLVED THAT the Board contact the Minister of Education to express concern regarding the misuse of FSA data by the Fraser Institute or by any individual or organization that uses such results to rank schools; and

THAT the Board further suggest to the Minister that if there is no effective way to manage the FSA data so it cannot be used for the purposes of ranking, then such assessments should cease and should be replaced by random sampling provincial assessments. <u>CARRIED</u>
