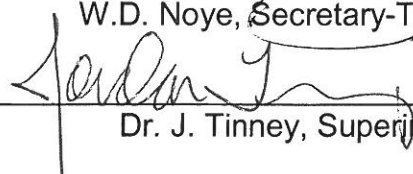

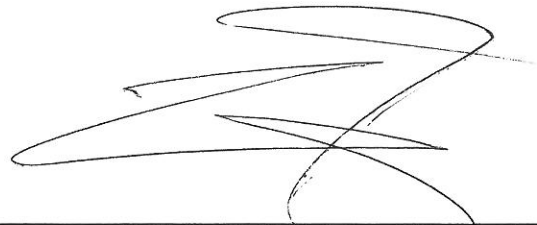

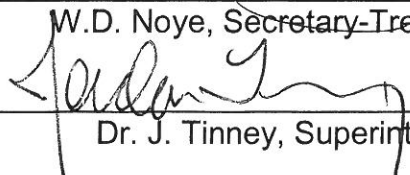

**[1] CALL TO ORDER**

Chairperson Wilson called the meeting to order at 7:02 p.m.

Trustees, Administration and the audience sang "O Canada" accompanied by a recording by Lena Shaw Elementary students.

(c) Presentation - Student Ambassadors, Energy Conservation and Sustainability – Jennifer Callaghan

Jennifer Callaghan, Energy Ambassador's Coordinator, BC Hydro School Programs provided Trustees with information regarding the Energy Ambassadors program and introduced the following student ambassador's to address the Board:

Enver Creek Secondary, Lovdeep Singh, Mandeash Grewal; Johnston Heights Secondary, Estela Lauron, Farahnas Mohammad, Alfons Rimando, Shesha Adikari; Queen Elizabeth Secondary, Maryam Imran, Waseeta Tanweer, Johnny Nyugen, Simran Gill, Nitika Bassi; Semiahmoo Secondary, Ayush Bansal, Tina Zheng; Frank Hurt Secondary, Shery Sandhu, Harsuman Benipal, Balroop Gill; and Tamanawis Secondary, Prabjot Bamrah, Amandeep Bamrah.

The students outlined the various energy saving activities that they had introduced in their schools over the previous year. Accomplishments were highlighted and in addition, the ambassadors presented their school's energy saving goals for the future. Schools had reached out to Grade 7 students and elementary schools to engage them in energy savings as well. They are looking for support from the Board, administration, teachers and students.

Chairperson Wilson thanked the group on behalf of the Board, for their insightful presentations and their continued efforts towards energy conservation throughout the district. He also mentioned that the interaction with the elementary schools was very important as the younger students are very interested in care for the environment.

Trustees expressed their support for the work the Ambassadors do and for the difference Energy Ambassadors make by saving the district money every year. Trustees during the budget process are very aware of correlation between energy savings and monetary savings. They thanked the group for their hard work, for their influence in the district and expressed their support for the program.

Trustees expressed their appreciation for the teacher sponsors and Alasdair MacKinnon, Director of Energy Management and Sustainability was acknowledged for his work in supporting the program and in the district. Mr. Mackinnon will be retiring at the end of August and Mr. Noye thanked him for his many contributions to the district and for successfully engaging students in energy management. Mr. Mackinnon was chosen to work in the Energy Management area as he was a teacher and an administrator rather than a business person. He has done an exemplary job and the energy savings programs have continued to build under his leadership.

[2] **DELEGATIONS**

(a) French Immersion Parents – Douglas McCall

Erin Miller and Douglas McCall reported that parents are concerned about French Immersion in Surrey. On May 14<sup>th</sup> parents met to discuss the lack of space in the district for French Immersion. Mr. McCall presented facts regarding the financial funding for French Immersion. They would like to see a proven method to grow French Immersion in the district. They mentioned that there are 150 families who were left out of the program due to lack of space and are on wait lists. The communication with waitlisted families has been poor and people on the waitlist do not know where they stand. Improved communication, action and answers to requests for information were requested.

(b) Montessori Parents – Sandy More

Ms. More, PAC President, Mountainview Montessori Elementary, expressed concern regarding the potential restructuring of Montessori classrooms due to budget cut backs. She gave an overview of the program and the classroom groupings currently in place and mentioned that all students would be affected by the restructuring of classrooms and the illumination of a Grade 7 class. She stated that there are 80 families (375 students) who drive to the school and who are committed to the teachers and the Montessori program. Ms. More pointed out that the loss of a teacher would compromise the integrity of the program. She presented the Board with a petition with 282 signatures on it requesting that the Surrey School District continue to support the current structure at Mountainview Montessori Elementary.
