(e) Eligible School Sites Proposal 2015-2019 Capital Plan

It was moved by Trustee Allen; seconded by Trustee Holmes:

THAT based on consultation with City of Surrey and the City of White Rock on the Eligible School Sites Proposal (ESSP), the Board of Education of School District No. 36 (Surrey) estimates that there will be

28,086 (33,428 including suites) development units constructed in the school district over the next 10 years (Schedule 'A' – Table 2); and

THAT these 33,428 new development units will be home to an estimated 6,634 school age children (Schedule 'A' – Table 3); and

THAT the School Board expects 3 new school sites and 3 site expansions, over the ten-year period, will be required as the result of this growth in the school district and the site acquisitions will be located as presented in Schedule 'B'; and

THAT according to Ministry of Education site standards presented in Schedule 'B' these sites will require in total 12.6 hectares (approx. 31.1 acres). These sites should be purchased within ten years and, at current serviced land costs, the cost is estimated at \$58,384,717; and

THAT the 2015 Eligible School Sites Proposal be forwarded to Local Government for acceptance; and

THAT pending Local Government acceptance, the 2015 Eligible School Sites Proposal, be submitted to the Ministry of Education. CARRIED

Chairperson Wilson reported on Trustee activities since the last Board meeting. A copy of the report is on the website.

(b) <u>Progress Report Active Capital Projects</u>

Trustees received a progress report regarding active capital projects.

(c) Report on Business Development Financial Activity for the Twelve Months Ended 2015-06-30

Trustees received a report on the Business Development Financial Activity for the Twelve Months Ended 2015-06-30. Trustee Tymoschuk commended the Business Development department staff and Liane Ricou, Manager for the excellent work increasing donations by 50%.

(d) Class Size and Composition Report

Trustees received reports on the current class size and composition of the Elementary and Secondary Schools. Dr. Tinney mentioned that this is an annual report that was submitted to the Ministry, however, the District is no longer required to submit the report. All classes over 30 students have gone through the consultation process with the teacher. The Assistant Superintendents work closely with the Principals to balance the classrooms, taking into consideration the IEP's. Trustee Tymoschuk encouraged Dr. Tinney to continue to bring the Board this report. Trustee Allen asked if IEP's are increasing and what percentage of enrollment do IEPs represent. Dr. Tinney responded that he would refer the question to the Director of Instruction, Student Support, but stated that there is a dramatic increase in Autism.

(e) Update on Enrollment

Trustees received an update from Dr. Jordan Tinney on enrollment. The District currently has an additional 958 students over last year. Dr. Tinney thanked the Board for approving an additional ten teachers and emphasized that space continues to be an issue. He also mentioned that the District expects to welcome Syrian refugees in the near future. How many and where they will locate within Surrey is to be determined. Three District staff and Dr. Tinney will be attending a meeting regarding the Syrian refugees on Monday November 16th.

In response to Dr. Tinney's update, Trustee Holmes brought forward the following motion:

It was moved by Trustee Holmes, seconded by Trustee McNally:

THAT the Board of Education School District No. 36 (Surrey) direct the Chairperson to request a meeting with all Surrey and White Rock Members of Parliament in order to review and discuss the status of the Syrian refugees and their anticipated arrival in our schools. CARRIED
