2. Delegation

a. Surrey Teachers' Association - Ms. Sue Heuman

Salish Secondary School, located in North Clayton, at 7278 - 184 Street, Surrey, will accommodate 1,500 students, grades 8 - 12 in both regular and French Immersion programs. The target completion for the new school is spring 2018 and the project remains on schedule and budget.

The school is the first secondary school in Surrey that is specifically designed to embrace "Learning by Design" principles and features 10 learning communities that foster collaboration in support of the Ministry of Education new curriculum.


