

# **Mountainview Montessori Code of Conduct**

"In our Montessori school we learn together peacefully and responsibly by caring for each other and the world"

This Code of Conduct is established for everyone's protection, safety, and well-being. At Mountainview Montessori we expect each person to strive towards excellence in learning, listen to others, demonstrate safety, and show respect towards other and property. While the code specifically addresses student behaviour, all members of the learning community are expected to conduct themselves in a manner that reflects tolerance, dignity, and respect. Our code is in accordance with the Provincial Standards for Code of Conduct.

## **Student Expectations**

Each student is expected to:

#### Show personal responsibility for learning

- Listen attentively and follow instructions
- Complete assigned work to the best of your ability
- Strive for excellence in your studies
- Be prepared for learning by being prompt, having the right materials, and taking care of your physical needs (rest, exercise and nutrition)Enable all to learn

#### Enable all to learn

- Work and move appropriately around the classroom and school
- Allow others to speak without interruptions or noise
- Accept and respect the contributions of others
- Be helpful and supportive of the efforts of others

### **Demonstrate Safety**

- Play in designated areas and use equipment appropriately
- Move in and around the school in a safe manner
- Adhere to school district expectations when utilizing technology and the internet
- Remain on school property unless specific permission is obtained to leave
- Ensure that the school environment is violence free by avoiding involvement in or condoning any form of violence of bullying (including cyber-bullying)
- Ensuring an environment free from abuse in any form (verbal, physical, sexual)
- Ensuring an environment free from Intolerance and discrimination in any form i.e. based on an individual or group's race, colour, ancestry, place of origin, political belief, religion, marital status, physical or mental disability, sexual orientation, gender identity or age.
- Refraining from any retribution against a person who has reported incidents.
- Avoid taking part in or condoning any form of threatening, marginalization or discriminating behaviour
- Not use or possess any weapon or replica weapon, intoxicating or illicit substances
- Report the presence of unauthorized persons on school property to an authorized adult

### Show respect toward others and property

- Treat others in a way that you would like to be treated
- Be mindful of others' feelings and respect their personal space
- Show respect and proper regard for all adults
- Use language that is kind, caring and respectful. Avoid harassing, swearing, racist or objectionable language. This includes language and symbols on clothing
- Wear clothing that allows one to fully participate in all school activities.
- No profanity or inappropriate slogans printed on clothing
- Refrain from theft, vandalism, graffiti and other inappropriate behaviours towards the property of others
- Show care of personal belongings

# **Electronics/Computer Use**

School computers and other electronic devices are only to be used for school/education related activities. They are not permitted for social networking, gaming, illegal, obscene or inappropriate purposes. Inappropriate use includes, but is not limited to, attempts to vandalize, gain unauthorized access to data or another person's account or resources, and sharing of data without personal or parental consent as appropriate. Recording of visual images or audio is not permissible at school unless permission has been received by the classroom teacher with respect to a classroom project.

Students are to be aware that they may be subject to discipline (or, if applicable, confiscation of personal property) for misuse of any technology, if it negatively impacts the school environment. Misuse of district technology services will lead to suspension of user privileges and possible disciplinary or legal action.

# School Phone/Personal Cell Phones/Bring Your Own Device (BYOD)

Parents are requested to convey personal messages to their child prior to leaving for school in the morning. Students will be allowed to use school phones in emergency situations only, with the permission of a staff member. Electronic devices are welcome at school, but only to support student learning in the classroom and under the direction and supervision of a teacher. Cell phone use during school hours is not permitted. However, students may use cell phones for communication with parents after school. Devices may not be used during recess or lunch breaks. During the day, cell phones are to be turned off and kept in student backpacks or will be held by the teacher. Inappropriate use and/or use outside of the above guidelines, will result in the device being taken to the office and returned to parents. The school will not assume responsibility for any devices damaged or stolen at, to, or from school.

#### Consequences and Discipline

Consequences will be applied in a fair and consistent manner, and will take into account the age, maturity and special needs (eg.Intellectual, physical, sensory, emotional or behavioural disability) of the student. Consequences will be progressive and will focus on being restorative rather than punitive in nature. Depending upon these and other factors, one or more of the following actions may be taken:

- Review of expectations or redirection
- Time-out
- Think sheet
- Loss of privileges

- School service
- · Contact with parents
- Counselling support
- Child Care worker support
- Meeting with parents
- Payment for damages, other restitution
- Enrolment in Steps to Success- alternative to suspension program
- Short term (in-school or at home) suspensions up to 5 days
- Involvement of support services (Agencies, medical assessments, police etc.)
- Long term suspension over 5 days
- Consultation with police and/or fire department
- Expulsion

Expect the Principal's involvement when solutions in the classroom have not worked in bringing about behavioural change. Possible consequences:

- 1. Review of behaviours/Warning
- 2. Letter home of concern
- 3. Alternative to Suspension Program
- 4. In-school suspension

When there is evidence of student use, possession, or trafficking of drugs (including alcohol) or other illegal substances and/or weapons, the student may be suspended and/or expelled from the school and all schools under the jurisdiction of this school board. A serious breach of suitable behaviour may result in a suspension for the first offence. The SAFE AND CARING SCHOOLS POLICY (#9410.2) provides specific direction for unacceptable behaviours, including contact of outside agencies for serious breaches of the Code of Conduct
