OFFICE HOURS:

Office hours are from 8:00 am to 3:00 pm, Monday to Friday. The school phone number is 604-581-2327. Please leave a voicemail message if you call outside office hours or if the line is busy.

ABSENTEES/LATES:

If your child will be absent or late, please phone the school before **9:00 am**. Please share your child's name, division, or teacher and reasons for absence. We will phone parents or emergency contacts if an absence has not been reported to the school. Your child's safety is our top priority. Students late to school must notify the office before going to class.

ILL/INJURED STUDENTS:

Please keep your child home if they are experiencing cold and/or flu symptoms and are unable to participate in all school activities, including recess and lunch. If an accident causing minor injury should occur at school, First Aid will be provided, the incident will be documented and parents will be notified. In the case of serious injury, parents will be notified immediately and 911 will be called, if required.

VISITORS:

All visitors to Hjorth Road Elementary are asked to enter through the main school doors and register at the office upon arrival. All visitors are required to wear a visitor badge while in the building.



Personal Digital Devices ...

are defined as any personal electronic device that can be used to communicate or to access the internet, such as a cell phone, tablet, laptop, or smartwatch. These devices are important tools which can be used to enhance learning and prepare children for the world in which they will work and live.

Personal digital devices provide support for children who rely on these tools to access learning through services such as translation, adaptations for Individual Education Plans, medical support, health needs, or to provide equity of access to resources. The classroom teacher is responsible for the learning environment in the classroom, for guiding children to use personal digital devices appropriately, and for determining when personal digital devices should be used.

The safe and responsible use of personal digital devices is expected by all Surrey School District students, employees, volunteers, parents, guardians, and community members who are on school district property or interacting with students or staff. This includes the following:

- Those using personal digital devices need to abide by the school code of conduct as well as all Provincial and Federal laws and the British Columbia Human Rights Code. This includes not using personal digital devices to engage or participate in bullying or harassment, discrimination, or defamation of character.
- At both elementary and secondary schools, personal digital devices can be used during class time to enhance learning at the direction of the classroom teacher. These devices should be used in a way that is respectful of other's learning and does not distract others in terms of light, sound, or by other means.
- At elementary schools, it is expected that personal digital devices are to be put away during non-class time such as recess and lunch. Exceptions to this are for students who need digital devices for medical or health reasons, translation, accessibility, or other student-specific reasons.
- Personal Digital Devices should not be used during lock down procedures or drills. The use of personal digital devices during this time may impact the emergency safety response.
- Surrey School District staff and students should not be recorded, visually or audibly, for any reason without their prior consent.
- The Surrey School District is not responsible for lost, missing, or damaged personal digital devices that students choose to bring to school.

STATEMENT OF PURPOSE

At Hjorth Road Elementary, we seek to enable learners to develop responsible life, citizenship and academic skills within a safe, caring environment in partnership with the community.

BEHAVIOUR EXPECTATIONS

Behaviour expectations and school policies are established for the protection, safety, and well-being of all students. At Hjorth Road Elementary, all members of our school community assume responsibility for their behaviour. All staff are committed to assisting students in developing conflict resolution, problem-solving, and decision making skills appropriate for their age.

Acceptable and unacceptable behaviour while at school, attending school-related activities (both on and off school grounds), or in any other circumstances where engaging in the activity will have an impact on the school environment. There are expectations of behaviour as students mature. It is important to note that acceptable and unacceptable behaviours listed below are not all-inclusive lists.

UNACCEPTABLE BEHAVIOUR:

As necessary, special considerations may be made for students unable to comply due to a disability of any nature.

In addition to the acts listed below in **SAFE & CARING SCHOOLS**, inappropriate behaviour can consist of, but is not limited to:

- Rudeness, swearing or inappropriate teasing
- Fighting, kicking, throwing objects and/or physically harming others
- Littering or vandalizing school property
- Defiant behaviour, insolence
- Running and/or yelling in the hallways
- Leaving school grounds without permission
- Unauthorized use of electronic devices on school property, including cell phones
- Use of bikes, scooters or skateboards during school hours

Hjorth Road Elementary CARES about our school environment. We:

- Show COMMUNITY by working with others and contributing to our school
- Show ACCOUNTABILITY for our actions
- Show RESPECT for ourselves, others, and our environment
- Show EMPATHY and kindness for others
- Act SAFELY at all times!

We use our WITS to solve problems. We WALK AWAY, IGNORE, TALK IT OUT AND SEEK HELP.

SAFE & CARING SCHOOLS ARE FREE FROM ACTS OF:

- Bullying (including cyber-bullying)
- Harassment, threats, intimidation and marginalization
- Violence in any form
- Abuse in any form (verbal, physical, sexual)
- Intolerance and discrimination in any form, i.e. based on an individual or group's race, colour, ancestry, place of origin, political belief, religion, marital status, family status, physical or mental disability, age, sex, sexual orientation, gender identity or expression.
- Retribution against a person who has reported incidents

SAFE & CARING SCHOOLS DO NOT TOLERATE THE PRESENCE OF:

- Intoxicating or banned substances (including alcohol, cigarettes, vaping and drugs)
- Theft and vandalism (or damage to personal property)
- Weapons or replica (toy) weapons (including laser pointers); explosives (including fireworks) and pepper or other obnoxious sprays
- Intruders or trespassers (all visitors must first report to the office)
- Inappropriate clothing or unacceptable slogans imprinted on clothing

SAFE & CARING SCHOOLS MONITOR THE USE OF ELECTRONIC DEVICES/COMPUTERS

- At Hjorth Road Elementary, personal devices must not be used on school property between 8:30 am and 2:28 pm. During the day, devices must be stored on silent mode in the student's backpack or locked in the teacher's cupboard.
- School computers and other electronic devices are only to be used for school/education related activities. They are not permitted for social networking (except as directed by a teacher), gaming, illegal, obscene or inappropriate purposes. Inappropriate use includes, but is not limited to, attempts to vandalize, gain unauthorized access to another person's account or resources, and sharing of data without personal or parental consent as appropriate.
- Recording of visual images is not permissible at school unless permission has been received by the classroom teacher with respect to a classroom project.
- Students are to be aware that they may be subject to discipline (or, if applicable, confiscation of personal property) for misuse of any technology, if it negatively impacts the school environment.
- Misuse of district technology services will lead to suspension of user privileges and possible disciplinary or legal action.

CONSEQUENCES

At Hjorth Road Elementary, we strive to develop socially responsible students and specifically teach, model and encourage caring and socially responsible behaviour. Consequences will reflect the age, maturity and special needs (e.g. intellectual, physical, sensory, emotional or behavioural disability) of the student, as well as, severity and frequency of actions. Consequences will be progressive and will focus on being preventative and restorative rather than punitive in nature. Depending upon these and other factors, one or more of the following actions may be taken:

- Review of expectations and restorative action where possible
- Review of expectations, written reflection assignment and/or loss of privileges
- Parents informed, meeting with parents
- Referral for counselling, behaviour support and/or School Based Teach (SBT)
- Short-term suspensions up to 5 days (in-school at the office), with the CYCW or at home
- Long-term suspension over 5 days or referral to a District program
- Consultation with police and/or fire department
- Expulsion

As students at Hjorth Road Elementary become older and more mature, it is expected that they:

- Understand there are increased consequences for inappropriate behaviour
- Increase their sense of personal responsibility and self-discipline

NOTIFICATION

Hjorth Road Elementary administration and staff have a responsibility to advise parties as follows:

- Parent/guardian of student exhibiting major behaviour problem every instance
- Parent/guardian of student on the receiving end of an incident every instance
- Assistant Superintendent, Safe Schools Department and/or other District staff
- Ministerial agencies and/or School Liaison Officer (RCMP)

OTHER

Students at Hjorth Road Elementary are expected to support the following:

Digital Citizenship at School

The use of personal devices at school is a privilege given to our students with the understanding that the following expectations will be respected and upheld at all times.

- All devices must remain in the student's backpack at all times while the student is on school property, inside and outside of the building.
- The use of electronic devices is not permitted during recess and lunch.
- Devices must remain in the student's backpack unless under direct supervision, and with permission, from the instructing teacher.

Consequences

- First offence: Device will stay with teacher, teacher to inform parent
- Second offence: Device to office until 2:27 pm, Principal to meet with student and inform parent
- Third offence: Loss of privileges. Device to remain at home or at office during the school day

School Assemblies

During the school year, students and staff at Hjorth Road Elementary enjoy a variety of assemblies. On occasion we warmly welcome parents, family and community members and thereby expect our students to:

- Enter and exit the gym in a quiet and orderly manner
- Respond quickly to the signal for quiet
- Listen respectfully to the presenter
- Participate respectfully and appropriately
- Leave all toys and fidget items in class, unless approved by staff
