Dear Lena Shaw School community,

Please find below a notification from Fraser Health. This notification is an alert that someone within the school community has tested positive for COVID-19.

Please note: This individual was **not** in the same class as your child.

The person involved has been isolated and there is no chance of direct exposure at this time.

Our district is committed to transparency and we will continue to notify our school community of COVID-19 exposures at our schools as soon as public health informs us.

What happens next?

- If Fraser Health identifies anyone at the school that needs to self-monitor or self-isolate, they will be contacted directly. That contact often occurs within 24 to 48 hours but may be shorter or longer depending on the circumstances.
- If you do not receive a phone call or letter, please continue to attend school and monitor for <u>symptoms</u> compatible with COVID-19 as per our school policy.

Again, please see the attached letter for additional information from Fraser Health. For privacy reasons, we cannot provide any further details.

# Early Notification - Not Exposed

Date:December 16, 2020

Dear Parent,

We are writing to let you know that someone with COVID-19 was at your child's school. We also want to let you know the steps Public Health is taking to protect the school community.

If you are reading this letter, your child was not in the same class as the person with COVID-19. The person involved has been isolated. Because of this, there is no chance of direct exposure at this time.

The person with COVID-19 was at your child's school, Lena Shaw Elementary, 14250 100a Ave, Surrey, BC on:

December 10 and 11, 2020

The actions the Public Health team is taking are:

- We work to trace the person's contacts to find out how the person got infected and who they
  were in close contact with.
- We investigate the exposure at the school so we can quickly find out if any staff or students need to isolate (self-isolate) or monitor for signs of COVID-19 (self-monitor).
- We phone the staff and students who were in close contact with the person and need to self-isolate.
- We might send letters to some staff and students and ask them to self-monitor for symptoms of COVID-19.

This letter does not mean Public Health will be contacting you. Public Health will only contact you if you or your child was directly exposed to COVID-19.

## We ask you to:

- Please continue to send your child to school.
- Continue to monitor your child for signs of COVID-19 each day using the Daily Health Check supplied by your school.

For privacy reasons, we cannot give any specific details about the exposure except for what is in this letter.

# Early Notification - Not Exposed

### How is COVID-19 transmitted?

This virus is spread by liquid droplets in the air. These droplets get into the air when an infected person coughs, sneezes, talks, or sings. Droplets can come from their nose, mouth or throat. These droplets can land on you if you are close by. The virus can also spread by touch. If droplets are left on objects and surfaces, you could become infected by touching these objects or surfaces. The virus enters the through the eyes, nose, or throat.

## What if you or your child gets sick?

If you or your child have symptoms of COVID-19, even mild ones:

- Isolate that person from others at home right away.
- Get assessed using the BC Self-Assessment Tool.
- Get tested for COVID-19 as soon as possible.
   If you are not sure if you should be tested, here are your options:
  - Call 8-1-1.
  - Contact your family doctor.
  - Call the Fraser Health Virtual Care Team.
     1-800-314-0999 (10:00 a.m. to 10:00 p.m. daily)
- Follow the directions given to you by the testing location on how long to self-isolate.
