Call for Nominations:

The following positions are vacant:

Chair:

- Shall convene and preside at all membership, special and executive meetings
- Shall ensure that an agenda is prepared and presented
- Know the constitution and bylaws and meeting rules
- Be the official spokesperson for the organization
- Ensure the PAC activities are aimed at achieving the objectives and purposes of the organization

Vice-Chair:

- Shall assume all the responsibilities of the Chairperson in the absence of the Chairperson
- Shall assist the chairperson as requested
- May be a signing officer

Secretary:

- Shall record the minutes of the membership, special and executive meetings
- Shall distribute minutes to council members and Principal by e-mail within 5 days of the meeting
- Shall safely keep all records of the council minutes and correspondence received by the PAC
- Shall keep an accurate record of the constitution and bylaws and if/when changes are made amended copy is prepared, presented, signed and dated

DPAC representative:

- Shall ensure the annual membership registration form is filled out and forwarded to the DPAC prior to cut off date.
- Shall attend the DPAC meeting
- Shall seek input and discussion topics to bring forth at the DPAC meetings
- Shall report to the PAC the meeting findings and discussions held at the DPAC meetings

Treasurer:

- Shall be responsible for and report on the accounts of the organization
- Shall be one of singing officers of the Executive
- Shall prepare a financial report for each month and present it with the agenda at the months meeting
- Shall with the assistance of the executive, draft a budget and tentative plan of expenditures
- Shall summit a year end report
- Shall make an application for the yearly gaming grant

Fun Food Coordinator:

- Shall hold a current Food Safe Certificate
- Shall organize volunteers for Fun Food
- Shall determine vendor, product list, dates and costs
- Shall send a list to the principal for review and Cc: Chairperson
- Shall organize order forms for parents with the school office
- Shall tally orders and count money; give to treasurer for deposit using deposit form
- Shall request vendor cheque payment from Treasurer and remit to vendor when possible, will
 ensure receipts are submitted to treasurer for reimbursement

Fundraising coordinator:

- Shall present fundraising options and/or ideas at PAC meetings for discussion and approval by executives
- Shall coordinate fundraising events and lead parent volunteers
- Shall maintain a fundraising opportunity file
- Shall collect order forms from the office and/or divisions
- Shall check monies against orders and forward monies to the Treasurer
- Shall coordinate and organized delivery of fundraising merchandise, sort out order and ensure delivery is made


