## Hazelmere Pumpkin Patch Fieldtrip



Dear Parents and Guardians,

We have booked a trip for the students to visit The Hazelmere Pumpkin Patch on **Monday October 28<sup>th</sup>**.

We will be using parent drivers for this field trip. Parent drivers are to arrive at the school for 8:30. We will return to the school before lunchtime. **All parent drivers must have a Volunteer Driver Form on file** with the school and have their Driver's License and Insurance Documents verified at the office. **A new form is required for each school year** and you need a form and your documents verified even if you are only driving your own child.

**The cost for students is \$8. They will get to take a pumpkin home.** Please pay on-line at: <https://surreyschools.schoolcashonline.com/> .

### Other Fees:

Parents are \$5 (without a pumpkin)

Siblings are free if under 2 years (does not include pumpkin), or \$8 (with pumpkin).

### Here are some important details:

- \* **WEAR BOOTS & RAIN PANTS!** The Pumpkin Patch is often muddy and pumpkin leaves are itchy!
- \* **Bring bags** for the children to carry their pumpkins in. **Cloth bags are best!**
- \* Students and teachers have wagon priority. Parents and siblings may have to wait behind or walk to the pumpkin patch.
- \* **Children must be able to carry their own pumpkins.** Parents are more than welcome to purchase extra or larger pumpkins during your visit. Pumpkins are priced by size.
- \* We ask that parents **do not use the concession** at the front gate.
