# Principal Report - Fiona Ekhert

The events so far this year have been successful. The Winter Dance was outstanding.

The Hip Hop was fun, it changed the energy in the school. The leader was encouraging and positive. Thank you to the PAC for making that happen.

Next year, we are looking at doing something different, ie: Aquarium Aquabus, whole school involved in a pumpkin field, Urban Safari, a company that does coding classes for the whole school. It has to supplement the teacher's curriculum. We can start researching ideas and present at the end of the year to plan for next year's calendar.

Basketball season us under way for 6 & 7's.

Seaside Volleyball rents the gym space and has purchased a new volleyball net for the school at a cost of \$600.

A grant was received to replace the metal folding chairs that are kept under the stage. 100 folding plastic chairs on a cart have been purchased. 50 more chairs and another cart needs to be purchased. The carts will be kept on the stage and will be taken up and down with the elevator. This will free up space to store gym equipment under the stage.

Three areas for the PAC to focus funds. A quote will be sent to the PAC.

- 1) Folding chairs
- 2) Technology for the play, such as a new soundboard and new mics (some will be purchased, some will have to be rented depending on the cost).
- 3) 20 additional iPads with keyboards. 10 are at the school for primary grades, 10 are waiting to be picked up for the intermediate grades.

Frozen Jr is going well. There will be a mini Spring Break surprise performance in early March.

Pink Shirt Day and the Kindness Assembly are coming up in February.

#### **Community Outreach**

The spring book drive is under way. So far 16 boxes of books have been donated. There will be a coat and mitten drive in February. Extra money from the Toonie drive was used to purchase mittens \$25.

Bridgeview is in need of basic school supplies. There will be a school supply drive at the end of the year for the school to have for September.

### **New Business**

We are on a wait list for a second Crossing Guard.

Neighbors have come by because of concerns ie: U-turns, stopping in the road, etc at pick up and drop off. The police have been coming by when they can to monitor. A light is needed at the new cross walk.

There was a consultation with Safe Schools and the Kiss and Go situation here is one of the safest as far as flow goes.

Helping Hands has \$1400 in surplus. Consider what to do with the money, as only \$300 can be carried over.
