# **Course Outline**

#### **Overview:**

The goal of Social Studies is to develop thoughtful, responsible, active citizens, which can acquire information, consider multiple perspectives and make reasoned judgment. Law 12 will provide the student with the opportunity to study and learn the Canadian legal system. Understanding and asserting one's rights and living up to responsibilities is a crucial part of being an active citizen in our society.

#### Law 12 teaches students to:

- understand fundamental legal principles including equality, justice and liberty
- recognize and act upon their rights and responsibilities.
- identify legal elements in problems.
- prevent or address legal problems in everyday life.
- apply their learning about the law to their studies careers, and daily lives.

## **Course Content**



This will be an investigation into the sources, roles, and purposes of law in our society. Basic structures and processes that are used to administer and enforce the law will be discussed.

#### **Criminal Law**

Students will be challenged to answer key questions such as: why society criminalizes certain behaviours, what constitutes a crime, and how society deals with criminal behaviour.

#### **Civil Law**

Civil Law is broken further into two segments: Tort Law and Contract Law. Tort Law deals with disputes between parties and wrongs done to one another, while Contract Law looks at the various agreements, both formal and informal made between groups.

#### Law and the family

Students will explore the various laws and principles that govern family life, specifically as they relate to marriage, divorce, and responsibilities to children.

  Recognize that learning is your responsibility. For the time being it is your job. No one can make you learn if you don't want to.

### **Expectations:**

- Respect others' contributions and learning environment. (books, room and other feelings)
- Offer opinions and ask questions. (of the material, others and yourself)
- Keep your binder organized and up to date. (Record date, assignments, marks)
- Do quality work, something you are proud of

#### **Critical Thinking:**

Written case studies, films, and other electronic sources will be used in each unit to illustrate various legal challenges that arise in each field. Students will be asked to think critically about each case and legal issue, all the while knowing that there are few absolutely right and wrong answers.

- Quizzes, projects, and written assignments are to be complete in black ink, blue ink or computer printout.
