- * DO YOUR RESEARCH!
- * START NOW. It takes time to search, and there are some as early as September
- * Sign up and complete a profile to be matched
- * Prepare a calendar and mark the DUE DATES
- * Make sure you meet the eligibility requirements and qualify for the scholarship
- * Find out if you need transcripts and provide enough notice to the school office
- * Answer all (parts of the) questions with examples and passion. See examples in the Career Centre
- * If you need a reference, complete the "Request for Letter of Reference" and give people <u>at least</u> <u>3 weeks notice</u>
- * Have someone proof-read your work
- * Make sure all documents are included (transcripts, references, essays, resume, etc.)
- * Re-read the application instructions and submit accordingly

- Applications are accepted year-round. Please allow up to eight weeks for processing.

KEATCA: Knowledge, Education and Training Canada. Individual Grant Applications: https://keatca.org/grants-students-in-canada.php

- Students must be enrolled in a public post-secondary educational institution.
- Canadian applicants must have a family income of less than \$30,000 CDN per annum
- Foreign applicants must have a family income of less than \$30,000 CDN per annum in terms in terms of the <u>Purchasing Power Parity (PPP)</u> in their home countries.
- Grants cover only tuition fees or a part thereof for a degree, or a vocational or training program. Grants will be made for one year at a time and may be renewed.
- Grants will be paid directly to the educational institution or through the partner organization. KEATCA committees will determine the grant amounts based on need, availability of funds and the criteria

Canada Student Grants:

Grants are awarded on the basis of financial need, but unlike student loans, they do not have to be paid back. The program consists of a total of seven grants for full-time students, part-time students and students with permanent disabilities.

The Canada Student Grants Program works in conjunction with the Canada Student Loans Program. When you apply for a Canada Student Loan through your province or territory of residence, you will also be automatically considered for a Canada Student Grant. This means that you do not have to apply separately for a grant. If you are deemed to qualify for a grant, you will be notified how much money you will be receiving. You can receive more than one grant at the same time if you meet the eligibility criteria.

Application procedure: automatic assessment upon application for Canada Student Loan

Canada Student Grants for Full-time Students

Grant for Persons from Low-Income Families

Eligibility criteria:

- from low income family
- qualify for Canada Student Loan
- enrolled in full-time program (at least 60 weeks in duration)

Amount available:

- \$250 per month of study
- up to \$3,000 per academic year
- available for all years of undergraduate studies

Grant for Persons from Middle-Income Families

Eligibility criteria:

- from middle income family
- qualify for Canada Student Loan
- enrolled in full-time program (at least 60 weeks in duration)

Amount available:

- \$100 per month of study
- up to \$1,200 per academic year
- available for all years of undergraduate studies

Grant for Persons with Dependants

Eligibility criteria:

- from low income family
- have dependant under 12 years of age
- qualify for Canada Student Loan
- enrolled in degree, diploma or certificate program (at least 12 weeks in duration within 15 week period)

Amount available:

- \$200 per month of study, per dependant child
- available for all years of undergraduate and postgraduate studies

Canada Student Grants for Part-Time Students Canada Student Grants for Persons with Permanent Disabilities <u>Grant for Persons with Permanent Disabilities</u> Eligibility criteria:

- qualify for Canada Student Loan
- enrolled in full-time or part-time program (at least 32 weeks in duration)
- provide proof of permanent disability

Amount available:

- \$2,000 per academic year
- available for all years of undergraduate and postgraduate studies

Grant for Service and Equipment for Persons with Permanent Disabilities

Eligibility criteria:

- qualify for Canada Student Loan
- enrolled in full-time or part-time program
- provide proof of permanent disability and provide written confirmation of exceptional need

Amount available:

- up to \$8,000 per academic year
- available for all years of undergraduate and postgraduate studies

There are MANY awards and incentives for those pursuing the skilled trades and their Red Seal:

Apprenticeship Grants: Apprentices can receive up to \$4,000 in grants to pay tuition, travel, tools, etc.

- Apprenticeship Incentive Grant: The Apprenticeship Incentive Grant (AIG) is a taxable cash grant of \$1,000 per year/level, up to a maximum of \$2,000. This grant helps registered apprentices in designated Red Seal trades get started. Please consult the Apprenticeship Incentive Grant (AIG) program page for more information.

- The Apprenticeship Completion Grant (ACG) is a taxable cash grant of \$2,000. This grant helps registered apprentices who have completed their training become certified journeypersons in designated Red Seal trades. Please consult the Apprenticeship Completion Grant (ACG) program page for more information.

Employment Insurance for Apprentices while studying

- Apprentices registered with the ITA may be eligible for temporary Financial Supports while they attend ITA approved training for their apprenticeship. The Employment Program of British Columbia (EPBC) provides employment services and supports to apprentices and delivers it through a network of WorkBC Employment Services Centres (ESC's).

Canada Apprentice Loan

- The Canada Apprentice Loan offers interest-free loans to help registered apprentices with the cost of their training. Apprentices registered in a Red Seal trade apprenticeship can apply for interest-free loans of up to \$4,000 per period of technical training. Interest charges and repayment of the Canada Apprentice Loan will not begin until after loan recipients complete or terminate their apprenticeship training program.

BC Training Tax Credits

- > The BC provincial training tax credits provide income tax credits for employers and employees who are engaged in apprenticeship programs administered through the Industry Training Authority (ITA).
- > There are three main elements to the training tax credits:
 - basic credits for non-Red Seal training programs;
 - o completion credits for both Red Seal and non-Red Seal training programs; and
 - \circ enhanced credits for First Nations individuals and persons with disabilities.
