RE: T.E. Scott Elementary School (7079-148 St. Surrey BC) COVID-19 EXPOSURE

Dear Parent,

This letter is to provide early notification of a confirmed COVID-19 individual at your school on:

September 14 and 15, 2020

Public health staff have initiated contact tracing to identify any staff and students that need to self-isolate or self-monitor for symptoms.

Receiving this letter does not mean you have been exposed to COVID19.

The intent of this letter is to share information with the school community and advise you on next steps being taken by public health.

HOW IS COVID-19 SPREAD?

This virus is spread between people by droplets. This means you need to be close enough to be exposed to saliva or mucus from the mouth, nose or throat of the infected person.

WHAT HAPPENS NEXT?

- Phone calls will be made to staff and students that public health has identified as needing to selfisolate for 14 days from when they were exposed.
- Letters will be sent out to staff and students who will be asked to self-monitor for symptoms. These staff/students may continue to attend school while monitoring for symptoms.
- If you do not receive a phone call or letter continue to attend school and monitor for symptoms compatible to COVID-19 as per your school policies.
- For privacy reasons, we cannot give out any specific details on the COVID-19 exposure other than the information provided above.



SCHOOL COVID-19 EXPOSURE EARLY NOTIFICATION

WHAT IF YOU OR YOUR CHILD HAVE SYMPTOMS OF COVID-19?

- Isolate yourself and/or your child from others.
- Get assessed for COVID-19 as soon as possible.
- Contact 8-1-1 or your doctor to find out if you should be tested for COVID-19.
